Applicant: T-Mobile

Mr & Mrs Sargeant

- 50 yards from their property
- Children play close to the area (Chippy Jumps)
- Danger to health
- Visual impact
- Very close to The Royal Oak beer garden / play area
- No significant reasons why mast cannot be put in another area
- No significant reasons for chosen location

Mr & Mrs Palfrey

- Similar concerns as Mr & Mrs Sargeant
- Aesthetically surprising to put mast in that location
- Suggested location is part of the National Cycle Route
- Impact on visitors to the area
- Feel it should be tucked away from sight
- Goes against what we have been working towards for the village (BKV)
- Concerns about health impacts.

Mr & Mrs Rogers

- Concerns about health implications
- Feel that the impacts have not been fully investigated.

Mr Paul Boston

- Health concerns are paramount
- Aesthetics impact
- Feels it will show village in a bad sight
- No concern for people living in nearby surroundings
- Too near a children's play area
- Shows no consideration for local amenities
- Proposed site part of the National Cycle Route
- May deter people from using the Playbuilder
- Wants reasons why this site was chosen out of 4 possible locations.

Cllr Mike Smith

- In agreement with the issues raised about health issues
- Government have set out guidelines and regulations for the emissions
- The frequency emissions may be detrimental to health
- Feels application should be refused in accordance to a report which states such applications should be implicated with precaution and should not be erected near school sites.

- Location may have been chosen in relation to cost (may be cheapest option)
- Need to get a consensus on where villagers would be happy to have the mast
- Feels it would be an unpleasant sight next to BKV sign
- Sees no reasons why it cannot be re-located on existing site

It was stated that Cllr Smith has called this application in and he suggested that one of the residents should register an interest with Stafford Borough Council's planning department, which would then allow them to raise their objections in front of the planning committee. It was confirmed that this would not be detrimental if any of the residents were to make an objection.
